Notification for issuance of Admit Cards and duplicate admit cards to conduct the written examination for recruitment of English Stenographer, English Typist –Copyist, LDC, and Process Server (Summon Bailiff) as per Notification No.1 dated 13.02.2013.

Admit Cards for 89 eligible candidates for the Post of English Stenographer, for 215 eligible candidates for the Post of English typist-Copyist, for 1394 eligible candidates for the post of LDC and for 715 eligible candidates for the Post of Process Server(Summon Bailiff) have already been issued by this Office by 30.06.2013 to conduct the written examination which will be held on 28.07.2013.
