Applications are invited from the eligible Indian Citizens in the following prescribed format for preparation of panel to fill up the existing and expected vacancies, mentioned below in different categories of posts, in the judgeship of Paschim Medinipur, West Bengal.

The examination/test of a particular category of post will be held on a particular day and time which will be conveyed accordingly. One can apply for only one vacant post. The appointment will initially be made on temporary basis but is likely to be made permanent as per relevant Rules for all categories of posts.

**Eligibility: Age, Minimum Qualification and other qualification required, Scheme and Syllabus for examination for each category of post are given below :-**

**1. Eligibility Age :**

Not less than 18 years and not more than 37 years as on 01<sup>st</sup> January, 2014 for all categories of posts. Relaxation of age limit for five years in case of candidates belonging to SC & ST Category
