

IN THE JUDGESHIP OF BIRBHUM

Notification for recruitment of different categories of posts of staff in the Judgeship of Birbhum, West Bengal to be conducted by the District Recruitment Committee of Birbhum Judgeship under the supervision of the Committee of Registrars of High Court at Calcutta.

Employment Notification No.01 dated Suri, the 27th. May, 2014.

Applications from the eligible Indian Citizens in the following prescribed format are invited for preparation of separate panels to fill up the existing and expected vacancies, mentioned below, in different categories of posts, in this Judgeship of Birbhum up to 31.12.2014.

The examination /test of a particular category of post will be held in a particular day and time in the district of Birbhum. One can apply for only one vacant post. Details of vacancies, scales of pay, details address of the appointing authority to whom the application is to be addressed and in whose favour the respective applications fees is payable are given here under:-

The application is to be address to " **The District Judge, Birbhum, PIN-731101**".

Mode of Payment of Application Fees.

1. Application Fees by Demand Draft to be drawn in favour of **District Judge, Birbhum**, payable at State Bank of India, Suri.
2. Banker's Cheque of State Bank of India will also be acceptable.
3. The applicant may also deposit application fees in ordinary Bank deposit form in SB A/c No.31832926615 of " District Judge, Birbhum, of State Bank of India, Suri Branch. In such case the candidate is instructed to write his / her full name in depositors' column and the applicant should enclose the Original Bank Deposit Slip with the application. The Bank charges if any shall be borne by the applicant himself / herself if deposited other than Suri Branch of State Bank of India.

The appointment will initially be made on a purely temporary basis but is likely to be made permanent, for all categories of posts.

Eligibility Age, Minimum Qualifying and other qualification required, Scheme of examination and Syllabus for each examination for each category are given below:-

1.Eligibility age: Not less than 18 years and not more than 40 years as on 1st. January, 2014 for all categories of posts . Relaxation of age limit for five years in case of candidates SC/ST category and for 3 years in case of candidates of OBC Category only. The upper age limit, in case of Physical Handicapped Candidate, is 45 years. Relaxation of age limit in case of Ex-Serviceman Category -as per existing Government Rules.
