- 2.Mere empanelment of the names of candidates in excess of the declared vacancies in terms of Notification No. CT.CVL.CRT 1 dated 13.02.2013 of this Court, will not automatically create any right of appointment.
- 3.Appointments of the selected candidates from the above panels in order of merit will be strictly made in accordance with the vacancy positions published in the Employment Notification No. CT.CVL.CRT 1 dated 13.02.2013. That means no alteration of vacant posts, already declared, will be made.
- 4.The Panels shall remain valid for one year from the date of publication in the Website of Hon'ble High Court at Calcutta or till all the vacancies are filled up by the successful candidates of the respective Panels, which ever is earlier.
- 5. The selected candidates shall be appointed purely on temporary basis in terms of the West Bengal Service (Appointment, Probation & Confirmation) Rules, 1979.
- 6.The selected candidates, whose mother-tongue is not Bengali, is required to pass Bengali in Departmental Examination in terms of the Advertisement under Notification No. CT.CVL.CRT 1 dated 13.02.2013 and in case of failure, they shall be terminated from the post.
- 7. The successful candidates are required to collect their Police Verification Form and to re-submit the same after duly filling up all the columns therein as and when directed to do so at the Office of Chief Judge, City Civil Court, Calcutta. They are also required to submit authentic attested copies of their all testimonials including documents of proof of age and caste etc. In case of suppression of any educational

qualification and / or caste, etc. by them during submission of duly filled up Police

Verification Form, this department shall not give any benefit/privilege to them in

future for such qualification or status. In case, any successful candidate, who does not

submit the duly filled up Form with other copies of documents by the date fixed, then

the said candidate will be treated to be unwilling to join the post and in his / her place

the next Wait Listed candidate in order of merit will be offered the opportunity to join

the post subject to fulfillment of the requisite criteria. It is hereby made clear that in

such event, any prayer of the candidate treated to be unwilling to join the post for the

above reason, for reconsidering his / her candidature as successful candidate will not

be entertained.

8. The date(s) & place for undergoing Medical Fitness Examination of the candidates

will be notified shortly.

9. The candidates whose names appear in the Final Panels shall not have any right to

claim the post merely on the ground that their names have been published in the

category of successful candidates. The District Recruitment Committee, City

Court, Clcutta as well as the Appointing Authority reserves the right to de-list the

name of any candidate from the Final Panel(s), if it is subsequently found that the

candidate is not otherwise suitable for the post.

10. The District Recruitment Committee, Calcutta, as well as the Appointing Authority

also reserves the right to make any alteration / change / rectification in the Final

Panels, if it is subsequently found and detected that due to bonafide arithmetical or

clerical mistake, if any, the name of any candidate has been erroneously inserted in the

Final Panels.

11.All appointments of the candidates from the Final Panels shall strictly be in

accordance with and shall abide by the Rules and Regulations of the Government of

West Bengal regarding Appointment now in force.
