The name of the Departments and locations of the places where network connections are to be installed are furnished at Schedule 'A'.

The bidding company must be an ISO certified company and must be in existence in the said business for a minimum period of three years. The bidding company must have a full-fledged support office at Calcutta. Documentary evidence in support of all the above eligibility criteria must be furnished along with the tender.

The price quoted must include all taxes and duties. The general terms and conditions for providing support are to be stated clearly in the document.

The equipment/components of LAN and the Networking shall be warranted for a period of three years from the date of delivery of the equipment/components and implementation of LAN respectively and any defect observed in the components or in the LAN during the said period shall have to be rectified with the equipments/ components of the same make as original at no additional cost.

vendors may inspect the site on any working day during office hours. For any clarification the interested vendors may contact Sri Susanta Chowdhuri, Nazir-in-charge, City Civil Court, Calcutta between 1 p.m. and 3 p.m. on any working day.

The Project Monitoring Committee may accept the tender whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price. However, the Project Monitoring Committee is not bound to accept the lowest tender.

The Project Monitoring Committee preserves the right to accept or reject any quotation and cancel the bidding process and reject all quotations at any time.

The sealed tenders are to be submitted in the office of the Registrar (Listing) High Court, Appellate Side, Calcutta on the 2nd floor of the High Court main building between 1 p.m. and 4.30 p.m. on any working day during the above-mentioned period.

The sealed tenders will be opened on 22nd June 2009 at 3 p.m. in presence of the intending bidders or their authorized representatives in the office of the Registrar (Listing) on the 2nd floor of the main building, High Court, Calcutta.
